

### A LETTER FROM THE PRESIDENT AND EXECUTIVE DIRECTOR

Dear Friends and Supporters,

As Cayuga Community College celebrates its 70th anniversary this year, the Cayuga County Community College Foundation continues to invest in our students, faculty, staff, and facilities on both the Auburn and Fulton campuses. We are proud that the College plays a pivotal role in enhancing our communities—whether through academic programs, workforce development, or as centers for community gatherings. This role becomes even more significant as Central New York looks to capitalize on investments from the MICRON Chip endeavor. We are confident that the College will leverage these opportunities and their offshoots.

This year, the College Foundation made several key capital improvements, including the completion of the new Workforce Development Center on Grant Avenue in Auburn and the new Law Enforcement Academy in Fulton, both of which are set to open in early 2025. These projects were made possible by leveraging SUNY Matching Funds, a testament to the strong partnership between the College, the Foundation, and our supporters.

In addition to these infrastructure investments, the College and Foundation have also focused on creating new programs and scholarships to increase enrollment. The changing demographics of Central New York and New York State require us to remain flexible and strategic in recruiting students to our campuses.

A notable new initiative by the Foundation, is the Early College Pathways Scholarship, a \$250,000 investment over the next several years. This scholarship will reward students who have worked hard to earn college credits while completing their Regents diploma in high school. We believe this investment will not only benefit individual students but will also strengthen our communities and increase enrollment at Cayuga.

We are also proud to announce a number of new scholarships established this year, including a scholarship in memory of the late Dr. Robert Lubanski, Huhtamaki of Fulton, David Morabito of Fulton, the Auburn Polish Falcons, and the Mary Porcari Brady Fund. These scholarships will support students in the Nursing Program, those pursuing liberal arts degrees and scholarships for students embarking in careers in the trades.

In addition to larger investments, the Foundation understands that smaller, targeted initiatives can have a profound impact. One such initiative is funding student attendance at lectures in Syracuse, where they have the opportunity to engage with authors and award-winning artists – experiences that can be transformative.

As you will see in the following pages of this Annual Report, the College Foundation is not only committed to raising funds for the College, but also to being careful stewards of our endowment. Over the past several years, our endowment has seen substantial growth. What began with seed money of just \$1,572 in 1982 has now grown to over \$19.4 million.

The College Foundation deeply appreciates the continued support and generosity of our donors. Your contributions make Cayuga Community College the shining jewel it is.

## RENOWNED POLITICAL CARTOONIST WAS VISITING SCHOLAR







This year's Brunell Visiting Fellow, funded by the College Foundation, was Pedro X. Molina, a world acclaimed practicing political cartoonist, originally from Nicaragua. In 2018 he received the Inter American Press Association Cartoonist Category award. In December of the same year he was forced to flee his home country when the offices of the *Confidencial* news outlet where he worked were raided, ransacked, and then occupied by the government of Daniel Ortega. He arrived in Ithaca on Christmas day as a resident artist of the Ithaca City of Asylum program where he lives and works, continuing to create and publish cartoons while living in exile.

Cayuga Community College students were introduced to Mr. Molina's work in the Fall when he visited classes and gave a public presentation about cartooning.

In the Spring semester, he taught a course on the Auburn campus: *Special Topics* – *Cartoons, Comics, and Graphic Novels*. Students have had a great experience developing a new skillset in this unique course. Students in this special-topics class had an opportunity to showcase their work in an on-campus exhibition, as well as in a publication of their cartoons. The publication will be printed and distributed after the conclusion of the course.

The student exhibition, as well as an exhibition of Molina's cartoons opened on Wednesday, May 1<sup>st</sup>. An artist talk and reception coincided with the exhibit opening. It was a special opportunity to hear from a world-renowned cartoonist here at Cayuga Community College.

## FOUNDATION SUPPORTS NEW EARLY PATHWAYS SCHOLARSHIP

Cayuga Community College has announced a new scholarship starting this Fall that will reward students for their hard work and dedication to earning college credits while completing their Regents diploma.

Thanks to a generous \$250,000 gift from the Cayuga County Community College Foundation, the Early College Pathways Scholarship is now available for eligible students. The scholarship recognizes high school students who commit themselves to earning credits through Cayuga's concurrent enrollment offerings.

The annual scholarship is another example of the Foundation's commitment to creating financial pathways for determined high schoolers to continue their academic journey at Cayuga.

"The Early College Pathways Program is a double win for the College Foundation to fund", according to Foundation Executive Director Guy Thomas Cosentino "... it not only helps students in Cayuga and Oswego counties further their education, having already taken Cayuga courses, but also helps to increase enrollment on both of our campuses."

"We're very appreciative of the Foundation's generous support for our students and this new scholarship," said Dr. Cathy Dotterer, Cayuga's Vice President for Student Affairs. "Many students arrive at Cayuga having challenged themselves in high school to complete college courses and earn credits toward their chosen degree. This scholarship recognizes and rewards their commitment." Eligible students must successfully complete a minimum of three Cayuga credits through concurrent enrollment. They must also submit an admissions, FAFSA and TAP application by July 15, be enrolled as a full-time student the semester after their high school graduation, and maintain good academic standing.

Students who earned 3-11 credits in high school can receive an annual award of up to \$500, and students who earned 12 or more credits are eligible for an annual award of up to \$1,000. The scholarship is applied annually for up to two years, and is applied after all other financial aid is applied.

The Early College Pathways Scholarship can also be combined with the Presidential Scholarship at Cayuga, another financial opportunity generously supported by the Foundation.

The new scholarship dovetails with the Early College Pathways Program announced this summer by Cayuga. 18 | 2024 CCCC FOUNDATION ANNUAL REPORT The Pathways Program creates clearly defined routes for high school students to earn college credits toward a specific degree program at Cayuga.



Simultaneously earning high school and college credits creates an accelerated pathway for students to transfer or, in the case of Auburn High School grad and Cayuga alum **James Mark '22**, start their career.

Mr. Mark (pictured above on the right) completed his high school degree while earning numerous college credits, then received his A.A.S. in Electrical Technology from Cayuga at no cost. He started at Waygate Technologies upon graduating, soldering cable harnesses before he was 20 years old. He was recently promoted to Shop/ Plan Operator-Expert, and discussed his experience at a conference this Summer on our Auburn Campus.

"The progress made from graduation to being a new hire to earning my first promotion has been rapid, and an amazing journey," said Mr. Mark. "In conversations at work, we still use terms and topics I learned at Cayuga, so I doubt I'd be this far along if it wasn't for that experience. I highly encourage everyone to consider a similar pathway to earn their high school and college degrees while preparing for their chosen career field."

Initiatives like the Pathways announced by Cayuga are essential to preparing the future workforce, said Dr. Gretchen Schmidt, a Senior Fellow at the National Center for Inquiry and Improvement and the guest speaker at the conference.

Citing evidence from a recent study from Georgetown University's Center on Education and the Workforce, titled "The Future of Good Jobs," Dr. Schmidt said future careers that lead to a living wage will require a post-secondary credential. *Continued on page 19.*

"The work that Cayuga is undertaking in partnership with local school districts is critical for the economic mobility of members of your community but also for overall economic growth in the region," said Dr. Schmidt.

"By working together, in more innovative and collaborative regional partnerships focused on programs that lead to a living wage, educational institutions and employers can increase economic opportunity for current and future students. This is hopeful work — for students, their families and the community at large."

Connecting high school students to career pathways has also drawn support from district leaders at CiTi BOCES and Cayuga-Onondaga BOCES, as well as Marq Brown, Vice President of Human Resources and Chief People Officer at Oswego Health.

"As the Baby Boomers continue to exit the workforce, it's critical that we provide opportunities for Generation Z students to explore pathways into industries that are already seeing shortages," said Brown. "Five years ago, Oswego Health partnered with Cayuga Community College and three local high schools in an Early College Health Sciences program to create these pathways. Our first cohort of 24 students just graduated, each with over 30 college credits toward healthcare programs like nursing and medical imaging."

CiTi BOCES District Superintendent Christopher Todd said collaboration between educational institutions and industry leaders will lead to stronger results for students. "At the Center for Instruction, Technology & Innovation, collaboration is at the heart of everything we do," said Superintendent Todd. "We are dedicated to fostering a cooperative environment where ideas and expertise converge to enhance educational experiences. By working together, we can create innovative solutions and provide valuable opportunities that open doors to student success."

The Early College Pathways are the latest addition to Cayuga's concurrent enrollment initiatives. The College currently has diverse programming agreements with 31 school districts across Central New York, offering high school students the opportunity to earn credits toward a college degree.

In the Summer of 2021, Cayuga President Brian Durant, then Foundation Board President John Latanyshyn and Foundation Executive Director Guy Cosentino met to discuss the capital needs of the College. One item long on Dr. Durant's list of "things to do", as with several of his predecessors, was installing an HVAC system in Spartan Hall.

The need, especially after the pandemic, to have better air flow for Commencement ceremonies, the College's Craft Fair and sporting events was readily evident. The Foundation worked with Dr. Durant and College staff to not only install a new system in Spartan Hall, but make enhancements to the already existing, but antiquated system, at the Norman F. Bourke Memorial Library. The Foundation committed funds to this project that could be matched by New York State. College staff was able to access CARES Act funds through the Higher Education Emergency Relief Fund, that allowed the Foundation's funds to be switched to a new and exciting project that will be soon announced for the Auburn Campus.

At the direction of President Durant, a plaque noting the Foundation and Board of Trustee's leadership and support of the new and upgraded air handling systems was unveiled before a Cayuga Women's Basketball game on January 31<sup>st</sup>.


